Contingent liabilities and future obligations

During this financial year, the Group Executive made the decision to retain the use of two minibuses and a van, but in order to facilitate this one of the minibuses was sold before winter with a view to purchase its replacement in Spring 2018. By way of preparation for vehicle replacements, back in 2016 we set up a separate designated vehicle fund (although physically it was kept in the same bank account as our other designated dulidings fund). In order to facilitate its purchase, at the end of March a sum of £9000 was transferred to the cheque account which was duly paid out in April. These transactions spanned the financial year end, hence this purchase is NOT reflected in these accounts but will instead appear in the 2018/19 accounts. It is brought to your attention in these notes to explain the apparent surplus that we carry forward where the vehicle fund is depleted, but an inordinately high value is shown in the cash funds/current account.

All of the Group's assets are listed on a separate sheet. The nature of these assets are, in some cases specific to the requirements of the Sea Scout Group. That is to say, their worth to the working of a Sea Scout Group is higher than the actual financial value that may not be realised if the items were to be sold. Without these items the Group would not function. All of the high value "capital" assets are in excess of 3 years old.

The Group has exclusive use of their own HQ building, for which they pay a ground rent to the local council, and business rates at a reduced rate. This is of wooden construction comprising 40"x20" hall, kitchen, toilets, meeting room, secure store room and boat workshop. There is also a double garage sized boat store, a small metal container store (12'x8"), a large container store (20'x8") and a car park for approx. 6 cars. Whilst of limited value on the open market, these facilities are crucial to the running of the Group.
